



DRAWBACK.NET 2009

LITE VERSION

The LITE Version of the Drawback.NET 2009 is a package designed for those Drawback filers that file on a small scale.

The LITE Version as well as all other Versions of Drawback.NET 2009 is a Microsoft SQL based application.

WHAT WILL THE LITE VERSION DO FOR YOU ?

- Allows the user to enter data via the keyboard or by downloading from another source such as a main frame computer.
- Processes and creates a drawback claim for either unused or manufacturing drawback depending on the System features you license.
- Automatically down-posts the import inventory used to create the claim.
- Checks for DUPLICATE ENTRIES and prohibits them from the System.
- Prints all the substantiating reports that accompany the drawback claim such as the Export Summary Report, A.D.E.P.S. Coding Sheet and the Designation Reports.
- Creates the U.S. Customs mandated diskette to be filed with your drawback claim. Should you prefer to send your drawback claims into Customs by way of ABI, the same diskette information can be sent to DutyCalc's ABI Service Bureau for submission. (see the DDS ABI Service Bureau information sheet)



THE DRAWBACK.NET LITE VERSION

- Accepts sets of unused (same-condition) merchandise and use the Bill of Material processor portion of the System to expand the exports when multiple imported components are packaged together as a set for exportation.
- Allows users to globally "search and replace" large groups of import and export data at once.
- Allows users to go back into the System and "undesignate" a claim and start over again.
- Allows users to control the matching process of exports to imports on a line item by line item basis. We refer to this feature as "line item confirmation".
- Allows users to perform a "global hold and unhold" on either imports or exports to prevent this data from being claimed for drawback. Data can be released from this hold whenever the user is ready to claim it for drawback.

HIGHLIGHTS

IMPORT, EXPORT and BILL OF MATERIAL DATA can be entered via keyboard or downloaded from a mainframe or other source.

DRAWBACK CLAIM REPORTS INCLUDED AS DRAWBACK CLAIM ATTACHMENTS

...include imports sorted by import entry number, imports claimed sorted by import part number, Exporters Chronological Summary by date, Exporters Summary by part number and the A.D.E.P.S. coding sheet.

ADDITIONAL REPORTS

...show all imports and quantities withdrawn for Drawback and the values and duties paid. The System user has a choice when it comes to sorting and printing data. You can limit reports to either include or restrict certain items. A report can be created to show all exports in the System, those that have been claimed, those that are still entirely unclaimed and those partially claimed with balances remaining to be claimed in the future. Export balances remaining apply to unused (same-condition) claims as well as to manufacturing claims where one export may require many different imported components or raw materials.



THE DRAWBACK.NET LITE VERSION

VERIFICATION

...is automatically performed to all imports entered or downloaded into the System. Verifications such as valid import entry numbers, correct dates and port of import codes are performed. Running balances of available import quantities are also strictly maintained to always ensure that inventory is depleted properly when Drawback claims are filed. Items fully depleted for Drawback are deemed unusable for further claims and can be sent to an archive file for historical use.

MORE VERIFICATIONS

...are automatically performed on all exports entered or downloaded into the System. The System also ensures that an export is claimed only one time. By way of our unique DUPE SCAN program, the System automatically checks for duplicate records.

MANDATED DISKETTE/CD FILING CAPABILITY

...is incorporated into the System. The System will create the diskette or CD with the necessary information U.S. Customs is requiring. This diskette or CD must accompany the corresponding Drawback claim when it is submitted to U.S. Customs for payment.

HISTORICAL REPORTS CREATED BY THE LITE VERSION

...include reports showing all exports and drawback amounts for either unused (same-condition) or finished good (manufactured) items including claim numbers and amounts paid. With use of our unique Report Builder, reports can be generated that are sorted by many different methods. For instance, a report can be created to restrict a certain item or group of items, it is your choice. Reports can be generated showing imports claimed for Drawback, the correlating claim numbers as well as the amounts paid. The Report Builder can be used to create an abundance of user generated reports for all kinds of tracking purposes.

ADDITIONAL HIGHLIGHTS

THE DRAWBACK.NET MANUAL

...is provided with the LITE Version. In addition to on-line help screens which assist users throughout the program, the Manual has just about all the answers to any questions you may have. It has been said that the Drawback.NET Manual is "extremely informative" and "easy to read".
