Requirements:

DRAWBACK.NET 2008 requires 50 to 100 megabytes to load program, MS-SQL Server Standard (can be purchased through Dutycalc or other source). User will need minimum 2GHZ CPU, 1GB RAM, Windows 2000 or better, preferably Windows XP IBM/PC or compatible equipment, any monitor

(All recommended hardware and software must be in place prior to installation)
